Introduction to Guidelines E-News

What is Guidelines E-News?

Guidelines E-News is a periodic report delivered electronically via email by the Maryland State Commission on Criminal Sentencing Policy (MSCCSP). It replaces its predecessor, Sentencing Fax, and provides information on the system of voluntary guidelines for the State's circuit courts. This issue of Guidelines E-News highlights several recent additions to the MSCCSP website and provides a few tips for completing the sentencing guidelines worksheet. Future issues will highlight any changes to the guidelines, report on sentencing trends using data from the sentencing guidelines worksheets, and provide useful information on worksheet submission.

Additions to the MSCCSP Website

There are a number of recent additions to the MSCCSP website (www.msccsp.org).

Completing the Guidelines Worksheet

The most common mistake when completing the sentencing guidelines worksheets is the omission of required information. The following are frequently overlooked items:

- Disposition Type
- Reason for Departure (if the actual sentence departs from the guidelines range)
- Was the offender sentenced to a Corrections
 Options program under Commission criteria?
 (Drug Court Yes No Other Yes No)

With regard to the above item on Corrections Options, it is important that the person completing the worksheet check either *Yes* or *No* for *Drug Court* AND *Yes* or *No* for *Other*. If the offender was not sentenced to a Corrections Options program, do not leave the item blank but instead check *No* for *Drug Court* and *No* for *Other*.

It is also important to be aware that home detention is considered a Corrections Options program. If an offender was sentenced to home detention, the person completing the worksheet should check *No* for *Drug Court* and *Yes* for *Other*.
