

Key Takeaways

- The <u>7th Circuit</u> has the highest number of manslaughter convictions.
- Relative to other types of manslaughter, defendants convicted of voluntary manslaughter receive, on average, the longest non-suspended sentence.
- Over half (52%) of voluntary manslaughter convictions involve a firearm or explosive.
- Voluntary manslaughter convictions are more likely than other manslaughter convictions to be disposed of via a jury trial.
- Sentences for most types of manslaughter are more likely than all person offenses to depart above the quidelines.
